CAPE Innovation Courses

Sections 1003.4203 and 1008.44, F.S., were amended to establish a new type of course which combines academic and career content with performance expectations that will result in college credit and industry certification attainment. These courses are called CAPE Innovation Courses. According to the statutory framework, each approved CAPE Innovation Course must have at least two third-party assessments, one of which must be associated with an industry certification on the CAPE Industry Certification Funding List. These courses are eligible for additional full-time equivalency (FTE) membership in the Florida Education Finance Program (FEFP), as specified in s. [1011.62\(1\)\(o\)1.c.](#), for student completion of the required performance outcomes.

CAPE Innovation Courses

- Students enrolled in AP Courses cannot generate funding under both sections of the statute

No additional FTE	Student does not earn a score of “3” or higher on the AP exam and/or does not earn the industry certification	
0.16 FTE	Student earns a score of “3” or higher on the AP exam AND does not earn the industry certification	s. 1011.62(1)(n), F.S.
0.3 FTE	Student earns a score of “3” or higher on the AP exam AND earns the industry certification for the CAPE Innovation Course	s. 1011.62(1)(o), F.S.

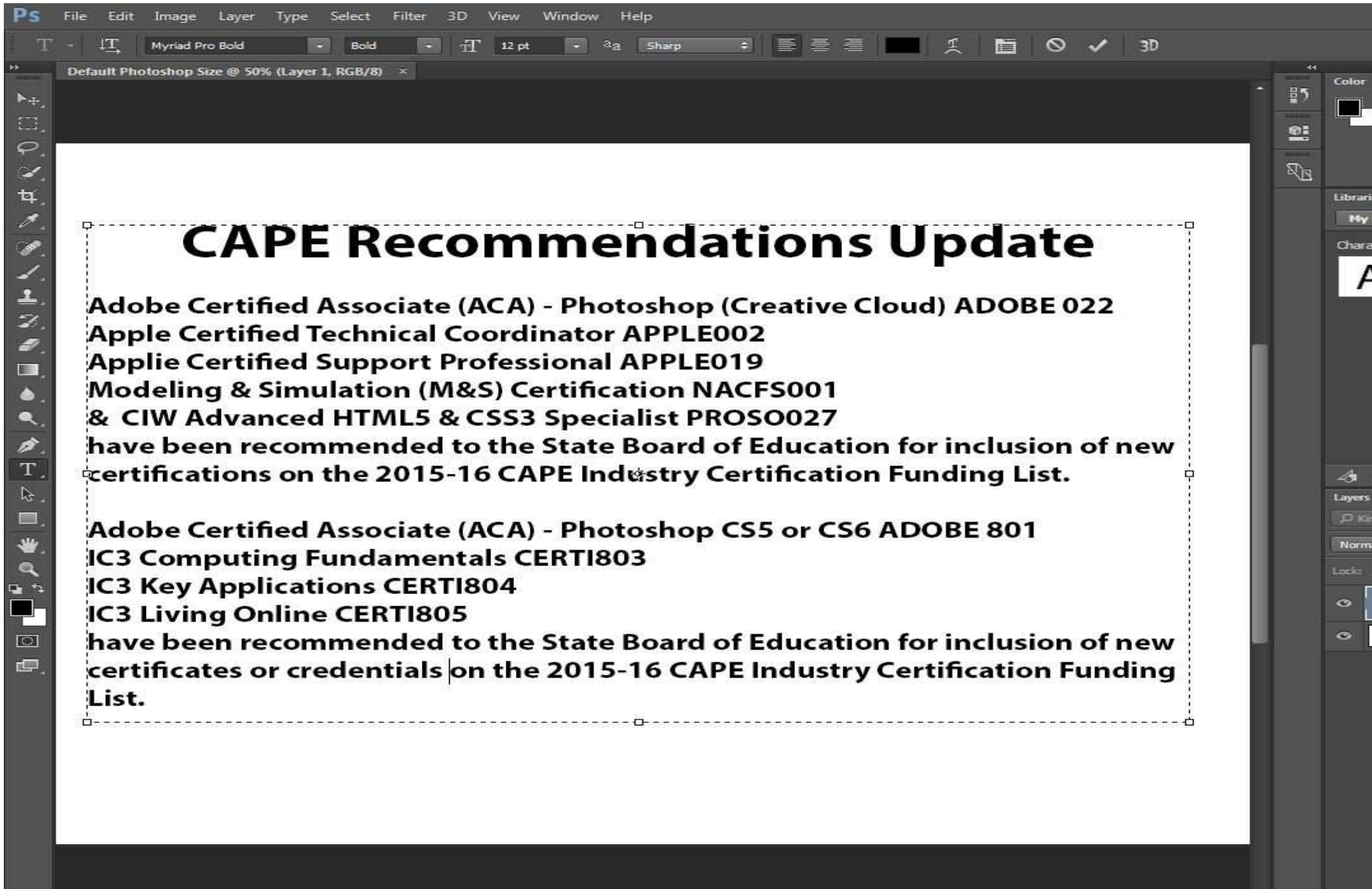

March 1, 2015	CareerSource Florida makes their recommendations to the DOE
March 5, 2015	DOE distributes a preliminary 2015-16 CAPE Industry Certification Funding List
March 5, 2015 to April 1, 2015	DOE has an open submission window during which districts may submit requests for additions to the CAPE Industry Certification Funding List
June 15, 2015	Districts notified of the recommendation for inclusion on the CAPE Industry Certification Funding List through a posting on the Department's web site. Recommendations for CAPE Digital Tool Certificates are posted as well
August 1, 2015	2015-16 CAPE Industry Certification Funding List is published
Summer/Fall 2015	State Board of Education adopts the 2015-16 CAPE Industry Certification Funding List
